Academic Transfer (Junior and Community College) Scholarships (\$500 per semester-fall and spring) are awarded annually to outstanding students who transfer from junior or community colleges. Southern Methodist University (Dallas)

Dallas-area Community College Scholarships (Collin, Dallas, and Tarrant). Each year the university awards 10 full-tuition scholarships for up to five semesters of full-time enrollment for students enrolled at Dallas, Tarrant, or Collin County community college systems. Criteria include at least 50 hours of transferable credit hours with a minimum 3.7 grade point average. Candidates are selected and interviewed individually by University committee. Essay and two-three letters of recommendation required. Renewable if full-time enrollment and a 3.0 grade point average are maintained. Fall entry only. All application materials, including transcript, must be received by May 15.

Honor Transfer Scholarships. Transfer students who have completed at least 50 transferable credit hours with a minimum 3.7 grade point average may qualify for half-tuition scholarships for up to five semesters of full-time enrollment. All students who qualify and have been admitted to the University Renewable if full-time enrollment and a 3.0 grade point average are maintained. Deadline below.

Community College Scholarships. Students transferring from a community college are eligible for \$1,500 per semester for up to five semesters. Students must have completed 50 transferable credit hours with a 3.5 grade point average. Deadline below.

Methodist Junior College Transfer Scholarships. Transfer students with at least 50 transferable credit hours are eligible to receive up to \$1,000 per semester for up to five semesters of full-time enrollment. Renewable if full-time enrollment and satisfactory progress are maintained. Deadline below.

Lon Morris College Transfer Scholarships. Transfer students with at least 50 transferable credit hours are eligible to receive \$1,000 per semester for up to five semesters of full-time enrollment. Renewable if full-time enrollment and satisfactory progress are maintained. Deadline below.

Phi Theta Kappa Honor Scholarships. Thirty, \$2,000 per year scholarships can be used as a supplemental scholarship to the Honor Transfer Scholarship (1/2 tuition) or the Community College Scholarship (\$3,000). Twenty of the scholarships are awarded in the fall and ten are awarded in the spring. These scholarships are renewable for up to five semesters as long as a 3.0 grade point average and full-time undergraduate status are maintained. Students must be active members of PTK who have completed at least 50 transferable credit hours with a minimum of a 3.5 grade point average. Texas A&M University (College Station)

Two-year College Transfer Scholarship. This scholarship is designed to recognize outstanding students who will be transferring to A&M from a two-year community college. To qualify, applicants 1) must be admitted to A&M prior to the fall semester but no earlier than the spring semester, 2) must have completed least 60 credit hours or an associate degree (with a minimum of 30 hours earned at the community college. In addition, the applicants current or most recent college attended must be a two-year institution.

Collegiate Excellence Scholarship. This scholarship is an academic scholarship for honors students from Texas community and junior colleges. The scholarship is awarded for one year and the amount is \$2,000. To be eligible, applicants must 1) be graduates of a Texas two-year community or junior college and its honors program, 2) be a US citizen or permanent resident, 3) have, at a minimum, a cumulative GPA of 3.5,

Texas State University (San Marcos)

Alumni Scholarship. The Alumni Scholarship is an academically competitive and renewable award of \$1,500. Students must have at least a 2.5 grade point average and a parent, grandparent, or sibling who has attended TSU. Renewable for up to 3 years based on academic performance.

Athena Scholarship for Women. This scholarship is for single, female student with financial need and custody of one dependent who is 17 year of age or younger. The award is for \$3,000 requires a 2.5 GPA.

Emmie Craddock Scholarship. Lunelle A. Anderson/Parents' Association Scholarship. This \$1,500 potentially renewable scholarship is competitively awarded to transfer students. Though the minimum requirement for consideration is that transfer students have at least a 3.0 grade point average, recipients tend to perform at a much higher level.

Martha St. Clair (Phi Theta Kappa) Scholarship. A \$1,000 award is available through this competitive scholarship program to two-year transfer students (graduates) attending TSU—3.0 GPA.

McCoy Foundation Scholarship of Merit. The McCoy College of Business Administration, like other colleges on campus, offers scholarships to students who will be majoring within one of their disciplines. The potentially renewable \$2,500—3.0 GPA scholarship is awarded to business majors on the basis of their

academic ability, essay, leadership, and involvement in extracurricular and volunteer activities, as well as other criteria.

MLK/Rivera Scholarship. This scholarship is for Texas residents with financial need and is academically competitive. Students must have participated in a subsidized lunch program, or be a first-generation college student, or participated in Upward Bound, Talent Search, CAMP, or Educational Opportunity Center program. The Trustee Award. This scholarship is valued from \$1,000 to \$12,000. Students who have excelled academically while taking a challenging curriculum are considered for this award.

Specifically, the University of Houston offers the President's Diversity Scholarship for Transfer Students. This scholarship is available for African American and Hispanic students who have completed at least 30 semester hours of transferable college credit with a cumulative grade point average of 3.0. Scholarships are renewable for up to three years. They are awarded to students in amounts ranging from \$500 to \$3,000, depending on the number of college credit hours the student has earned, as well as the grade point average established. These scholarships are renewable for up to three years with a minimum 2.5 grade point average. Students must be enrolled in at least 12 semester hours each fall and spring semester at the University of Houston.

Transfer Academic Excellence Award. Applicants must have completed 24 hours of college credit by the time they enter OU. Students with a 3.25 grade point average or higher will be given first consideration. Each one-year award provides a \$1,000 tuition waiver for full-time enrollment (12 credit hours) or \$500 for part-time enrollment (six credit hours).

Transfer Leadership Class Scholarship. The program recognizes outstanding transfer students. Participants are required to attend workshops and meetings throughout the year and participate in leadership/cultural programs on campus. The one-year award, based on academic performance and demonstrated leadership abilities, provides a \$1,000 tuition waiver. Applicants must have completed 40 hours of college credit by the time they enter OU and have a minimum 2.5 GPA. Students must be enrolled in a minimum of 12 hours to be considered for this scholarship.

The Phi Theta Kappa Alumni Association awards a scholarship based on academic achievement, participation in community or college activities and membership in PTK. To receive the PTK scholarship, students must have a 3.5 grade point average and have completed more than 24 credit hours at a two-year institution by the time they enter OU. The award provides a \$1,000 tuition waiver.

Academic Excellence Transfer Scholarship: These scholarships are one-year grants ranging from \$500-\$2,000.
